### Proof of identity

- Australian driver's license (with photograph, signature and current address)
- Current Australian passport
- Other proof of signature and current address details

\* Certified means that your proof of identify must be verified (i.e. signed and dated) by an authorised person (Justice of the Peace, doctor, teacher, pharmacist, legal practitioner, Postmaster – Australia Post).

## Application fee and processing charges

- Money order (Enclose a money order made payable to Racing NSW)
