

RACING NSW CLEAR DAY RULE CHART

THESE CHARTS RELATE TO THE RULES OF RACING WHICH PROHIBIT THE ADMINISTRATION OF SUBSTANCES OR TREATMENTS FOR A NUMBER OF CLEAR DAYS PRIOR TO A RACE, TRIAL OR JUMP OUT. THE RULES DEFINE 'CLEAR DAY' AS A 24 HOUR PERIOD FROM 12.00AM TO 11.59PM. THESE CHARTS SEEK TO ASSIST TRAINERS BY VISUALLY SHOWING THE DAYS ON WHICH SUBSTANCES OR TREATMENTS CANNOT BE ADMINISTERED.

THE YELLOW HIGHLIGHTS REPRESENT **CLEAR DAYS** ON WHICH THE SUBSTANCE OR TREATMENT CANNOT BE ADMINISTERED.

THE GREEN HIGHLIGHTS REPRESENT THE DAY OF THE **RACE, TRIAL OR JUMP OUT**. (NOTE: RESTRICTIONS BEFORE RACE, TRIAL OR JUMP OUT VARY WITH THE PARTICULAR RULES)

THE RED HIGHLIGHTS REPRESENT THE **LAST DAY THE SUBSTANCE OR TREATMENT CAN BE ADMINISTERED**. THIS MAY NOT CORRESPOND WITH THE WITHDRAWAL TIME OF INDIVIDUAL MEDICATIONS. ADVICE SHOULD BE SOUGHT WITH REGARD TO INDIVIDUAL MEDICATIONS.

THESE CHARTS SHOULD BE READ AND UNDERSTOOD IN CONJUNCTION WITH THE "RACING NSW CONTROL OF RACE DAY MEDICATION" INFORMATION POSTER.

 RANITIDINE (E.G. ULCERGUARD®)
 BROMHEXINE
 DEMBEXINE (SPUTOLYSIN®)

ANTIPARASITICS APPROVED AND REGISTERED FOR USE IN HORSES
 OMEPRAZOLE (E.G. GASTROZOL®, OMOGUARD®)
 ORALLY ADMINISTERED GLUCOSAMINE (E.G. JOINT GUARD®)
 ORALLY ADMINISTERED CHONDROITIN SULPHATE (E.G. COSEQUIN EQUINE®)

NOTE LR44A RESTRICTS THE USE OF ORALLY ADMINISTERED ALTRENOGEST CONTAINING PRODUCTS (E.G. REGUMATE®), WHEN ADMINISTERED TO FILLIES AND MARES WITHIN 1 CLEAR DAY OR RACING. SEEK GUIDANCE WHEN RACING OUTSIDE OF NSW.
